In terms of Section 110 of the Companies Act, 2013 and Rule 22 of the Companies (Management and Administration) Rules, 2014, including any statutory modification(s) or re-enactment(s) thereof for the time being in force, I hereby submit my Report as Scrutinizer for conducting the postal ballot voting process (including voting through electronic means) for passing of the special resolution on the following item:-

Item: Special Resolution for appointment of Shri A.S.Mehta as President & Director of the Company with effect from 1st October 2018 till 31st March 2022 on the terms of remuneration as set out in the Statement pursuant to Section 102(1) of the Companies Act, 2013.

The management of the company is responsible for ensuring compliance with the requirements of the Companies Act, 2013 and the relevant Rules for contents and passing of the resolution contained in the Notice of Postal Ballot dated 20th August, 2018.
